Position: Community Worker - Outreach and Development (CWOD)
Summer Employment - 30 hours/week

Responsibilities:

- Assist in data collection (demographic), preparation and implementation of surveys (face-to-face and electronic), canvassing neighbourhoods, collection, collation and analysis of the resulting data;
- Assist the MCR&V in all aspects of community engagement, including but not limited to identifying barriers and determining solutions to community engagement (traditional and non- traditional);
- Assist with conducting local needs assessments to determine preferred hours of operations, types of programs necessary/preferred and other considerations in program planning;
- Participate in the preparation and delivery of outreach programs, summer festivals and community celebrations;
- Assist staff in resourcing and accessing services that enhance accessibility (e.g. translation services, transportation etc.);
- Assist with the implementation of focused and dedicated outreach strategies to Caledon communities, setting meetings with community partners and stakeholders;
- Assist in maintaining an up-to-date database of stakeholders;
- Assist in developing strategies to enhance social and cultural inclusion.
